### September meeting - highlights

- CHIP will engage with the Minister for Children and Young People, Maree Todd, MSP with a view to her attending the next CHIP in December 2018.
- CHIP agreed to a future "Complexity & Home Supervision" event hosted by SCRA on 2/11/18. This event will look at what lessons for policy and practice, change and improvement we need to take from these key pieces of evidence and progress these on a partnership basis
- Learning and Development programme continues to work on the development of new materials (presently the "Role of the solicitor" is being produced) - it is the intention to deliver to all participants within a Hearing (see section on roles & responsibilities on the CHIP website).
- Our Hearings Our Voice is now actively recruiting young people to become directly involved in, influence and improve the work of the Hearing system in Scotland. CHIP members were encouraged to promote Our Hearings Our Voice, including the recent promotional material for member recruitment.

#### CHIP sub groups - an update

#### **Better Hearings sub group**

This group is the successor to the CHS/SCRA and Social Work Scotland Tripartite group which had done a great deal to ensure effective delivery of the 2011 Childrens Hearings legislation. The Better Hearings group is charged with overseeing the delivery of Better Hearings programme across Scotland and heard about the high levels of energy and commitment already in evidence amongst partners across the country. Most areas are focusing on key priorities such as:

- Improving the quality of reports to the Childrens Hearing including how children young people and their families can have their views much more visible.
- Ensuring supportive Pre-Hearing visits are offered to each young person before their Hearing in order to reduce anxiety and improve confidence and understanding.
- Improving written reasons of panel members so that they are more understandable and accessible.
